Chairman McKee called the meeting to order and introduced an ordinance to call a special election in Garland County, Arkansas on the question to establish a Fire Protection District for the Piney Fire Department. A motion for do pass was made by Justice Owen and seconded by Justice Raney. Chairman McKee asked for questions or discussion, and Justice Owen indicated there was no choice to pass it, since it is an ordinance to have an election. With nothing further, the motion passed without opposition.

Chairman McKee introduced an ordinance to call a special election in Garland County, Arkansas on the question to establish a Fire Protection District for the 70 West Fire Department.
