Chairman Owen called the meeting to order and introduced Resolution R-19-05 a resolution to confirm the reappointment of Karen Harbut to the Garland County Library Board of Directors for a second term. A motion for do pass was made by Justice Young and seconded by Justice Hunter. Chairman Owen asked for questions or discussion, with none the motion passed without opposition.

Chairman Owen called the meeting to order and introduced Resolution R-19-06 a resolution to confirm the appointment of J.M. Rowe and Gary West to the Royal Water Public Facilities Board. A motion for do pass was made by Justice Young and seconded by Justice Dixon. Chairman Owen abstained, due to his professional capacity as the facilities attorney. Chairman Owen asked for questions or discussion, with none the motion passed without opposition.

Chairman Owen introduced Ordinance O-19-23 an ordinance to amend the 2019 Budget Ordinance O-18-56 and to appropriate funds to the Jail budget for salary increases. A motion for do pass was made by Justice Braziel and seconded by Justice Young. Chairman Owen asked for questions or discussion, with none the motion passed without opposition.

Chairman Owen introduced Ordinance O-19-24 an ordinance to amend the 2019 Budget Ordinance O-18-56 and to appropriate funds to the Jail budget for the Chief of Corrections, the Detention Finance Manager, and the Expeditor/Investigator salary increases. A motion for do pass was made by Justice Young and seconded by Justice Braziel. Chairman Owen asked for questions or discussion, with none the motion passed without opposition.

Chairman Owen introduced Ordinance O-19-25 an ordinance to amend the 2019 Budget Ordinance O-18-56 and to appropriate funds to the Juvenile Detention budget for salary increases. A motion for do pass was made by Justice Dixon and seconded by Justice Braziel. Chairman Owen asked for questions or discussion, with none the motion passed without opposition.

Chairman Owen introduced Ordinance O-19-26 an ordinance to amend the 2019 Budget Ordinance O-18-56 and to appropriate funds to the Prosecuting Attorney's Budget for a salary increase to the Victim/Witness Supervisor and Coordinator of Major Crimes. A motion for do pass was made by Justice Braziel and seconded by Justice Young. Chairman Owen asked for questions or discussion, with none the motion passed without opposition.

Chairman Owen introduced Ordinance O-19-27 an ordinance to amend the 2019 Budget Ordinance O-18-56 and to appropriate funds to various budgets in the Sheriff's office. A motion for do pass was made by Justice Dixon and seconded by Justice Hunter. Chairman Owen asked for questions or discussion, with none the motion passed without opposition.

Chairman Owen introduced Ordinance O-19-28 an ordinance to amend the 2019 Budget Ordinance O-18-56 and to appropriate funds to various budgets and to establish the Garland County Teen Court Fund. A motion for do pass was made by Justice Young and seconded by Justice Braziel. Chairman Owen asked for questions or discussion, with none the motion passed without opposition.
