

APPROPRIATION ORDINANCE NO. O-18-28

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE PROSECUTING ATTORNEY BUDGET; AND, FOR OTHER PURPOSES.”

WHEREAS, previously funds were transferred to provide for grant expenses in the (VOCA) Victims of Crime Act Grant Fund; and,

WHEREAS, the Prosecuting Attorney received reimbursements from the State of Arkansas, Department of Finance and Administration for \$41,501.00 and requested an appropriation/transfer to reimburse the OMH Sale Fund; and,

WHEREAS, the Prosecuting Attorney requested an appropriation/transfer of \$15,388.63 from the County General Fund to reimburse the OMH Sale Fund for the county match; and

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. Anticipated Revenues for the (VOCA) Victims of Crime Grant Fund are \$41,501.00 and the Quorum Court may appropriate up to 100% of these anticipated revenues. The sum of \$41,501.00 is hereby appropriated from the (VOCA) Victims of Crime Act Grant Fund to the Prosecuting Attorney Budget in the following manner:

SECTION 2. That the sum of \$15,388.63 is hereby appropriated from the County General Fund to the Prosecuting Attorney Budget in the following manner:

SECTION 3. That the sum mentioned in Section 1 represents an increase of \$41,501.00 to the 2018 Prosecuting Attorney Budget in the (VOCA) Victims of Crime Act Grant Fund.

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$41,501.00 to the 2018 (VOCA) Victims of Crime Act Grant Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 2 represents an increase of \$15,388.63 to the 2018 Prosecuting Attorney Budget in the General Fund.


SECTION 6. That the sum mentioned in Section 1 has no effect on the 2018 General Fund Anticipated Revenue.


SECTION 7. That the sum mentioned in Sections 1 and 2 represent an increase of \$56,889.63 to the 2018 OMH Sale Fund Anticipated Revenues.

SECTION 8. That the County Treasurer and the County Judge are hereby authorized to execute completion of transfers as follows:
