

**APPROPRIATION ORDINANCE NO. O-18-29**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; AND TO APPROPRIATE FUNDS THEREFORE TO THE SHERIFF’S BUDGET, THE JUVENILE DETENTION BUDGET, AND THE COUNTY JAIL BUDGET; AND, FOR OTHER PURPOSES.”

**WHEREAS**, the Sheriff deposited \$18,789.30 with the County Treasurer in the General Fund for insurance reimbursements, three months of National School Lunch reimbursements, donations, restitution, and refunds; and,

**WHEREAS**, the Sheriff deposited \$1,082.21 with the County Treasurer in the Detention Facility Fund for restitution, extradition, and refunds; and,

**WHEREAS**, the Sheriff requested an appropriation of \$10,241.12 in the Sheriff’s Budget and \$6,669.25 in the Juvenile Detention Budget from funds received in the General Fund; and,

**WHEREAS**, the Sheriff requested an appropriation of \$973.99 in the County Jail Budget from funds received in the Detention Facility Fund; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** Anticipated Revenues for the General Fund are \$18,789.30, and the Quorum Court may appropriate 90% of these Anticipated Revenues.

**SECTION 2.** That the sum of \$10,241.12 is hereby appropriated from the County General Fund to the 2018 Sheriff’s Budget in the following manner:

**SECTION 3.** That the sum of \$6,669.25 is hereby appropriated from the County General Fund to the 2018 Juvenile Detention Budget in the following manner:

**SECTION 4.** Anticipated Revenues for the Detention Facility Fund are \$1,082.21, and the Quorum Court may appropriate 90% of these Anticipated Revenues.

**SECTION 5.** That the sum of \$973.99 is hereby appropriated from the Detention Facility Fund to the 2018 County Jail Budget in the following manner:

**SECTION 6.** That the sum mentioned in Section 1 represents an increase of \$18,789.30 to the 2018 County General Fund Anticipated Revenues.


**SECTION 7.** That the sum mentioned in Section 2 represents an increase of \$10,241.12 to the 2018 Sheriff's Budget.

**SECTION 8.** That the sum mentioned in Section 3 represents an increase of \$6,669.25 to the 2018 Juvenile Detention Budget.


**SECTION 9.** That the sum mentioned in Section 4 represents an increase of \$1,082.21 to the 2018 Detention Facility Fund Anticipated Revenues.

**SECTION 10.** That the sum mentioned in Section 5 represents an increase of \$973.99 to the 2018 County Jail Budget.


