

**APPROPRIATION ORDINANCE NO. O-18-31**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55, AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE 911 DISPATCH CENTER AND THE NINE-ONE-ONE BUDGET; AND FOR OTHER PURPOSES.”

**WHEREAS**, the County Judge is requesting an appropriation in the amount of \$4,532.11 in the General Fund, 911 Dispatch Center Budget to pay for a service contract on the 911 Dispatch Center’s analog recorder; and,

**WHEREAS**, the County Judge is requesting projected revenues of \$5,036.00 in the Emergency 911 Reserve Fund be brought forward to the beginning balance from savings; and,

**WHEREAS**, the County Judge is requesting an appropriation/transfer from the Emergency 911 Reserve Fund of \$4,532.11 to pay for the service contract noted above; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the sum of \$4,532.11 is hereby appropriated from the General Fund to the 2018 911 Dispatch Center Budget in the following manner:

**SECTION 2.** Anticipated Revenues for the Emergency 911 Reserve Fund are \$5,036.00 and the Quorum Court may appropriate 90% of these Anticipated Revenues.

**SECTION 3.** That the sum of \$4,532.11 is hereby appropriated from the Emergency 911 Reserve Fund to the 2018 Nine-One-One Budget in the following manner:

**SECTION 4.** That the sum mentioned in Section 1 represents an increase of \$4,532.11 to the 2018 911 Dispatch Center Budget.


**SECTION 5.** That the sum mentioned in Section 2 represents an increase of \$5,036.00 to the 2018 Emergency 911 Reserve Fund Anticipated Revenues.


**SECTION 6.** That the sum mentioned in Section 3 represents an increase of \$4,532.11 to the 2018 Nine-One-One Budget.
