

APPROPRIATION ORDINANCE NO. O-18-46

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; AND TO APPROPRIATE FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND FOR OTHER PURPOSES.”

WHEREAS, the County Judge deposited \$19,333.33 with the County Treasurer in the Solid Waste Fund for an insurance reimbursement from APERMA; and,

WHEREAS, the County Judge requests an appropriation of \$19,333.33 in the Solid Waste Budget from the funds received; and,

WHEREAS, the County Judge requests the 2018 beginning balance anticipated revenues in the Emergency 911 Reserve Fund to be increased by \$275,000.00; and,

WHEREAS, the County Judge requests an appropriation of \$245,000.00 in the Emergency 911 Reserve Fund, Nine One One Budget to pay the AT&T Hosted Solutions; and,

WHEREAS, the County Judge requests an appropriation of \$40,000.00 in the General Fund, General Services Budget to renovate the dome on the 4th floor; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the Anticipated Revenues for the Solid Waste Fund are \$19,333.33 and the Quorum Court may appropriate all of these revenues.

SECTION 2. That the Anticipated Revenues for the Emergency 911 Reserve Fund are \$275,000.00 and the Quorum Court may appropriate up to 90% of these revenues.

SECTION 3. That the sum of \$40,000.00 is hereby appropriated from the County General Fund to the General Services Budget in the following manner.

Line Item	Description	Amount
1000.0108.4006.J4	Construction in Progress- 4th Floor	\$40,000.00

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$19,333.33 to the Solid Waste Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$19,333.33 to the Solid Waste Budget.


SECTION 6. That the sum mentioned in Section 2 represents an increase of \$275,000.00 to the Emergency 911 Reserve Fund Anticipated Revenues.


SECTION 7. That the sum mentioned in Section 2 represents an increase of \$245,000.00 to the Nine One One Budget.

SECTION 8. That the sum mentioned in Section 3 has no effect on the General Fund Anticipated Revenues.

SECTION 9. That the sum mentioned in Section 3 represents an increase of \$40,000.00 to the General Services Budget.
