

**APPROPRIATION ORDINANCE NO. O-19-04**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”**

**WHEREAS**, the Sheriff has been awarded an additional \$3,000.00 in the Selective Traffic Enforcement Program (STEP) from the Arkansas State Police for distracted driving offenses. This grant is reimbursable and will require to be funded by the Ouachita Memorial Hospital (OMH) Sale Fund; and

**WHEREAS**, the Sheriff request an appropriation transfer for \$3,000.00 from the OMH Sale Fund to the STEP Fund; and

**WHEREAS**, the Sheriff has been awarded a Bulletproof Vest Grant for \$5,737.80, which includes the grant award of \$2,868.90, and the county match of \$2,868.90. The grant will require an appropriation /transfer from the General Fund for the 50% match; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** Anticipated Revenues for the STEP Fund are \$3,000.00, and the Quorum Court may appropriate up to 100% of these revenues.

**SECTION 2.** That the sum of \$3,000 is hereby appropriated from the OMH Sale Fund to the Special Projects Budget in the following manner.

**SECTION 3.** Anticipated Revenues for the Bulletproof Vest Fund are \$5,737.80, and the Quorum Court may appropriate up to 100% of these revenues.

**SECTION 4.** That the sum of \$2,868.90 is hereby appropriated from the General Fund to the Transfers Budget in the following manner:

**SECTION 5.** That the sum mentioned in Section 1 represents an increase of \$3,000.00 to the STEP Fund Anticipated Revenues.

**SECTION 6.** That the sum mentioned in Section 1 represents an increase of \$3,000.00 to the Sheriff's Budget.

**SECTION 7.** That the sum mentioned in Section 2 has no effect on the OMH Sale Fund Anticipated Revenues.

**SECTION 8.** That the sum mentioned in Section 2 represents an increase of \$3,000.00 to the Special Projects Budget.

**SECTION 9.** That the sum mentioned in Section 3 represents an increase of \$5,737.80 to the Bulletproof Vest Fund Anticipated Revenues.

**SECTION 10.** That the sum mentioned in Section 3 represents an increase of \$5,737.80 to the Sheriff's Budget.


**SECTION 11.** That the sum mentioned in Section 4 has no effect on the General Fund Anticipated Revenues.


**SECTION 12.** That the sum mentioned in Section 4 represents an increase of \$2,868.90 to the Transfers Budget.

**SECTION 13.** That the County Treasurer and the County Judge are hereby authorized to execute completion of the transfer as follows:
