Commission Code 01.00-C defines a "Resident" for the below purposes as a person who:

65 Plus Lifetime Licenses: Any person who physically inhabits a bona fide residence within Arkansas for a period of time no less than 60 days prior to applying for a license, and has declared citizenship in Arkansas.

Possession of Arkansas real estate by persons living outside the state does not qualify the owner as a resident.

Please Note: A **photocopy** of your current Arkansas driver's license or Arkansas I.D. card with an **issue date of 60 days or older** will satisfy both the proof of age and the proof of residency requirement.

An Arkansas driver's license or Arkansas I. D. card may be obtained from the nearest Department of Finance and Administration (DF&A) office.

A Photocopy of the methods of proof (both age and residency) should be enclosed with payment and a long self-addressed stamped envelope.
