

ORDINANCE NO. O-13-55

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND GARLAND COUNTY CODE 1987, CHAPTER 17, SECTION(S) 1-44, ORDINANCE-98-17, AS AMENDED BY ORDINANCE-03-8, THEREBY APPROVING THE MASTER ROAD PLAN AND SPECIFICATIONS; AND FOR OTHER PURPOSES.”

WHEREAS, the Garland County Code of 1987, Chapter 17, Section(s) 1-44 and Ordinance No. O-98-17, as amended by Ordinance No. O-03-8, previously established road plan specifications for residents of Garland County, Arkansas; and,

WHEREAS, the County Judge has updated and revised the current specifications and has gained committee approval to submit the Garland County Master Road Plan and Specifications to the full Quorum Court for approval; and,

WHEREAS, the Garland County Master Road Plan and Specification amendments are attached and marked as Exhibit “A”; and,

WHEREAS, the Public Health, Welfare & Safety and the Public Works and Buildings Committee have approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the Garland County Master Road Plan and Specification amendments are hereby approved as written (attached and marked as Exhibit “A”)

SECTION 2. That the Garland County Code of 1987, Chapter 17, Section(s) 1-44 and Ordinance No. O-98-17, as amended by Ordinance No. O-03-8, and all other Ordinances heretofore enacted by the Quorum Court of Garland County in conflict with this Ordinance are hereby repealed.


SECTION 3. SEVERABILITY. If any provisions of this Ordinance or the application thereto to any person or circumstances are held invalid, such invalidity shall not affect other provisions or applications of the Ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.


SECTION 4. This Ordinance shall be codified in the Garland County Code of Ordinances and the sections may be re-numbered and re-lettered to accomplish such intention.

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND O-13-55 WHICH PREVIOUSLY APPROVED THE GARLAND COUNTY MASTER ROAD PLAN AND SPECIFICATIONS; AND FOR OTHER PURPOSES."

WHEREAS, Ordinance O-13-55 was previously adopted approving the Garland County Master Road Plan and Specifications for residents of Garland County, Arkansas; and,
