## **APPROPRIATION ORDINANCE NO. 0-20-21**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND THE 2020 GARLAND COUNTY BUDGET ORDINANCE O-19-54; ANTICIPATE REVENUE, TRANSFER, AND TO APPROPRIATE FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES."

WHEREAS, the Sheriff requests to appropriate and transfer \$30,789.00 in the Edward Byrne Memorial Justice Assistance Grant (JAG) Fund, Sheriff's Budget to pay back the Ouachita Memorial Hospital (OMH) Sale Fund and to close the 2017 grant; and,

WHEREAS, the County Judge was awarded a Hazard Mitigation Grant Program (HMGP) of \$35,000.00 from FEMA to update the Hazard Mitigation Plan. This is a reimbursable grant that requires a 25% match; and,

WHEREAS, the County Judge requests a transfer of \$8,750.00 from the General Fund for the county's matching, and \$26,250.00 from the OMH Sale Fund to fund the HMGP Fund until the reimbursements are received; and,

WHEREAS, the Sheriff requests a transfer of \$7,799.82 in personal services to the supplies line item in the Boating Safety Fund, Sheriff's Budget; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

**SECTION 1.** That Anticipated Revenues for the JAG Fund are \$30,789.00, and the Quorum Court may appropriate 100% to the Sheriff's Budget.

**SECTION 12.** That the sum mentioned in Section 4 represents an increase of \$10,000.00 to the General Fund Anticipated Revenues.

**SECTION 13.** That the sum mentioned in Section 4 represents an increase of \$8,750.00 to the Transfers Out Budget.

**SECTION 14.** That the sum mentioned in Section 5 has no effect on the Boating Safety Fund Anticipated Revenues.

**SECTION 15.** That the sum mentioned in Section 5 has no effect on the Sheriff's Budget.

**SECTION 16.** That the County Treasurer and the County Judge are hereby authorized to execute the completion of the following transfers:
