

APPROPRIATION ORDINANCE NO. O-20-26

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2020 GARLAND COUNTY BUDGET ORDINANCE O-19-54; TO ANTICIPATE REVENUE, AND APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the County Judge requests an appropriation of \$155,000.00 in the Solid Waste Budget to replenish the Contractor’s Collection line for the Frontload Truck purchased in August; and,

WHEREAS, the County Judge requests an appropriation of \$97,149.00 in the General Fund, General Services Budget to pay the Arkansas Public Entities Risk Management Association (APERMA) for a total assessment; and,

WHEREAS, the Sheriff requests an appropriation of \$105.88 in the Emergency Vehicle Fund, Emergency Vehicle Budget to pay for radio equipment; and,

WHEREAS, the Sheriff deposited \$160.00 with the County Treasurer in the Boating Safety Fund from donations received and would like it appropriated in the Sheriff’s Budget; and,

WHEREAS, the Sheriff deposited \$5,228.82 with the County Treasurer in the General Fund for a donation, refund, three months of national school lunch reimbursements, and restitution. He would like \$225.00 appropriated in the Sheriff’s Budget and \$5,003.82 appropriated in the Juvenile Detention Budget; and,

WHEREAS, the Sheriff deposited \$1,900.57 with the County Treasurer in the Detention Facility Fund from reimbursements, restitution, and extraditions and would like it appropriated in the County Jail Budget; and,

WHEREAS, the County Judge requests increase anticipated revenues and appropriate \$15,290.01 in the Water System Fund 3401.0100, transfer \$105,290.01 to the General Reserve Fund 1001.0112 Beginning Fund Balance, and close the Water System Fund; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That sum of \$155,000.00 is hereby appropriated from the Solid Waste Fund to the Solid Waste Budget.

SECTION 10. That the sum mentioned in Section 2 does not affect the General Fund Anticipated Revenues.

SECTION 11. That the sum mentioned in Section 2 represents an increase of \$97,149.00 to the General Services Budget.

SECTION 12. That the sum mentioned in Section 3 does not affect the Emergency Vehicle Fund Anticipated Revenues.

SECTION 13. That the sum mentioned in Section 3 represents an increase of \$105.88 to the Emergency Vehicle Budget.

SECTION 14. That the sum mentioned in Section 4 represents an increase of \$160.00 in the Boating Safety Fund Anticipated Revenues.

SECTION 15. That the sum mentioned in Section 4 represents an increase of \$160.00 to the Sheriff's Budget.

SECTION 16. That the sum mentioned in Section 5 represents an increase of \$5,228.82 in the General Fund Anticipated Revenues.

SECTION 17. That the sum mentioned in Section 5 represents an increase of \$225.00 to the Sheriff's Budget.

SECTION 18. That the sum mentioned in Section 5 represents an increase of \$5,003.82 to the Juvenile Detention Budget.

SECTION 19. That the sum mentioned in Section 6 represents an increase of \$1,900.57 in the Detention Facility Fund Anticipated Revenues.


SECTION 20. That the sum mentioned in Section 6 represents an increase of \$1,900.57 to the County Jail Budget.


SECTION 21. That the sum mentioned in Section 7 represents an increase of \$15,290.01 in the Water System Fund Anticipated Revenues.


SECTION 22. That the sum mentioned in Section 7 represents an increase of \$15,290.01 to the County Judge's Budget.
