

**APPROPRIATION ORDINANCE NO. O-21-2**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**"AN ORDINANCE TO AMEND THE 2021 GARLAND COUNTY BUDGET ORDINANCE O-20-35; AND TO APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES."**

**WHEREAS**, the County Judge requests an appropriation of \$58,650.00 in the General Fund, Grant-In-Aid Budget to pay for the county's share of the District Judges' salaries; and,

**WHEREAS**, the County Judge requests an appropriation of \$34,957.28 in the General Fund, County Clerk's Budget to account for the County Clerk's Chief Deputy's salary and benefits that were not posted correctly in the budget ordinance; and,

**WHEREAS**, the County Judge requests an appropriation of \$1,229.70 in the Solid Waste Fund, Solid Waste Budget to account for a Lead Roll Off Operator's salary and benefits that were not posted correctly in the budget ordinance; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the sum of \$58,650.00 is hereby appropriated from the County General Fund to the Grant-In-Aid Budget.

**SECTION 5.** That the sum mentioned in Section 1 represents an increase of \$58,650.00 to the Grant-In-Aid Budget.


**SECTION 6.** That the sum mentioned in Section 2 represents an increase of \$34,957.28 to the County Clerk's Budget.
