

ORDINANCE NO. O-21-10

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND ORDINANCES O-19-55, O-20-08, O-20-11, O-20-13, O-20-35, O-21-6, AND O-21-9 TO ESTABLISH VARIOUS GRANT FUNDS; AND FOR OTHER PURPOSES.”

WHEREAS, the Circuit Court Division II Juvenile Judge would like to amend Ordinance O-19-55 and establish the Juvenile Court Incentive Grant Fund (3563); and,

WHEREAS, the Circuit Court Division II Juvenile Judge would like to amend Ordinance O-20-08 and establish the Juvenile Drug Court Accountability Grant Fund (3564); and,

WHEREAS, the Circuit Court Division II Juvenile Judge would like to amend Ordinance O-21-6 and establish the Courtroom Projection Project Grant Fund (3571); and,

WHEREAS, the Sheriff would like to amend Ordinance O-20-11 and establish the Sheriff’s Project Safe Neighborhood Grant Fund (3565); and,

WHEREAS, the Treasurer would like to amend Ordinance O-20-13 and establish the Stop the Bleed Kits Grant Fund (3566); and,

WHEREAS, the County Judge would like to amend Ordinance O-20-13 and establish the Coronavirus Emergency Supplement Funding Grant Fund (3567); and,

WHEREAS, the County Judge would like to amend Ordinance O-20-35 and establish the Garland County Safe Room Project Hazard Mitigation Grant Fund (3570); and,

WHEREAS, the Sheriff would like to amend Ordinance O-21-9 and establish the Peers Achieving Collaborative Treatment PACT Grant Fund (3572); and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. The Juvenile Court Incentive Grant Fund (3563) is hereby established.

SECTION 2. The Juvenile Drug Court Accountability Grant Fund (3564) is hereby established.

SECTION 3. The Courtroom Projection Project Grant Fund (3571) is hereby established.

SECTION 4. The Sheriff's Project Safe Neighborhood Grant Fund (3565) is hereby established.

SECTION 5. The Stop the Bleed Kits Grant Fund (3566) is hereby established.

SECTION 6. The Coronavirus Emergency Supplement Funding Grant Fund (3567) is hereby established.

SECTION 7. The Garland County Safe Room Project Hazard Mitigation Grant Fund (3570) is hereby established.

SECTION 8. The Peers Achieving Collaborative Treatment PACT Grant Fund (3572) is hereby established.

SECTION 9. As time is essential in establishing these funds, an emergency is hereby declared to exist, and this Ordinance shall be in full force and effect from and after its passage and approval.
