

**APPROPRIATION ORDINANCE NO. O-21-13**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**“AN ORDINANCE TO AMEND THE 2021 GARLAND COUNTY BUDGET ORDINANCE O-20-35; TO ANTICIPATE REVENUE, AND APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”**

**WHEREAS**, the Sheriff deposited \$2,302.89 with the County Treasurer in the General Fund for various reasons and would like \$452.13 appropriated in the Sheriff’s Budget and \$1,850.76 appropriated in the Juvenile Detention Budget; and,

**WHEREAS**, the Sheriff deposited \$200.00 with the County Treasurer in the Boating Safety Fund for donations and would like it appropriated in the Sheriff’s Budget; and,

**WHEREAS**, the Sheriff deposited \$1,353.01 with the County Treasurer in the Detention Facility Fund for extraditions, restitution, and a refund, which he would like to appropriate in the County Jail Budget; and,

**WHEREAS**, the Sheriff requests an appropriation of \$7,168.26 in the Detention Facility Fund, County Jail Budget to pay for equipping the transport van at the Detention Center; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That Anticipated Revenues for the General Fund are \$2,302.89, and the Quorum Court may appropriate \$452.13 to the Sheriff’s Budget and \$1,850.76 to the Juvenile Detention Budget.

**SECTION 2.** That Anticipated Revenues for the Boating Safety Fund are \$200.00 and the Quorum Court may appropriate these funds to the Sheriff’s Budget.

**SECTION 3.** That Anticipated Revenues for the Detention Facility Fund are \$1,353.01, and the Quorum Court may appropriate these funds to the County Jail Budget.

**SECTION 4.** That the sum of \$7,168.26 is hereby appropriated from the Detention Facility Fund to the County Jail Budget.

**SECTION 5.** That the sum mentioned in Section 1 represents an increase of \$2,302.89 in the General Fund Anticipated Revenues.

**SECTION 6.** That the sum mentioned in Section 1 represents an increase of \$452.13 to the Sheriff's Budget.

**SECTION 7.** That the sum mentioned in Section 1 represents an increase of \$1,850.76 to the Juvenile Detention Budget.

**SECTION 8.** That the sum mentioned in Section 2 represents an increase of \$200.00 in the Boating Safety Fund Anticipated Revenues.

**SECTION 9.** That the sum mentioned in Section 2 represents an increase of \$200.00 to the Sheriff's Budget.

**SECTION 10.** That the sum mentioned in Section 3 represents an increase of \$1,353.01 to the Detention Facility Fund Anticipated Revenues.

**SECTION 11.** That the sum mentioned in Section 3 represents a increase of \$1,353.01 to the County Jail Budget.

**SECTION 12.** That the sum mentioned in Section 4 will not affect the Detention Facility Fund Anticipated Revenues.

**SECTION 13.** That the sum mentioned in Section 4 represents an increase of \$7,168.26 to the County Jail Budget.


