

APPROPRIATION ORDINANCE NO. O-21-19

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND THE 2021 GARLAND COUNTY BUDGET ORDINANCE O-20-35; TO ANTICIPATE REVENUES, APPROPRIATE, AND TRANSFER FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES."

WHEREAS, the County Judge deposited \$43,653.80 with the Treasurer in the Solid Waste Fund from an overpayment of use tax of \$35,129.00, a reimbursement of \$3,449.90, and 2021 Spring Fling reimbursement of \$5,074.90. He would like these funds appropriated in the Solid Waste Budget; and,

WHEREAS, the Sheriff requests \$1,180.00 of the Edward Byrne Memorial Justice Assistance Grant (JAG) Fund match to be transferred from General Fund into to JAG Fund; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That Anticipated Revenues for the Solid Waste Fund are \$43,653.80, and the Quorum Court may appropriate \$43,653.80 to the Solid Waste Budget.

SECTION 3. That the sum mentioned in Section 1 represents an increase of \$43,653.80 in the Solid Waste Fund Anticipated Revenues.


SECTION 4. That the sum mentioned in Section 1 represents an increase of \$43,653.80 in the Solid Waste Budget.

SECTION 5. That the sum mentioned in Section 2 will not effect the General Fund Anticipated Revenues.


SECTION 6. That the sum mentioned in Section 2 represents an increase of \$1,180.00 in the Transfer out Budget.
