

APPROPRIATION ORDINANCE NO. O-21-24

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2021 GARLAND COUNTY BUDGET ORDINANCE O-20-35; TO ANTICIPATE REVENUE, AND APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the Sheriff deposited \$5,212.09 with the County Treasurer in the General Fund for various reasons and would like \$1,580.57 appropriated in the Sheriff’s Budget and \$3,631.52 appropriated in the Juvenile Detention Budget; and,

WHEREAS, the Sheriff deposited \$180.00 with the County Treasurer in the Boating Safety Fund for donations, which he would like appropriated in the Sheriff’s Budget; and,

WHEREAS, the Sheriff deposited \$1,435.62 with the County Treasurer in the Detention Facility Fund for extraditions and restitution, which he would like to appropriate in the County Jail Budget; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That Anticipated Revenues for the General Fund are \$5,212.09, and the Quorum Court may appropriate \$1,580.57 to the Sheriff’s Budget and \$3,631.52 to the Juvenile Detention Budget.

SECTION 2. That Anticipated Revenues for the Boating Safety Fund are \$180.00 and the Quorum Court may appropriate these funds to the Sheriff’s Budget.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$1,580.57 to the Sheriff’s Budget.

SECTION 6. That the sum mentioned in Section 1 represents an increase of \$3,631.52 to the Juvenile Detention Budget.

SECTION 7. That the sum mentioned in Section 2 represents an increase of \$180.00 in the Boating Safety Fund Anticipated Revenues.

SECTION 8. That the sum mentioned in Section 2 represents an increase of \$180.00 to the Sheriff's Budget.

SECTION 9. That the sum mentioned in Section 3 represents an increase of \$1,435.62 to the Detention Facility Fund Anticipated Revenues.

SECTION 10. That the sum mentioned in Section 3 represents an increase of \$1,435.62 to the County Jail Budget.
