

**APPROPRIATION ORDINANCE NO. O-21-33**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**“AN ORDINANCE TO AMEND THE 2021 GARLAND COUNTY BUDGET ORDINANCE O-20-35; TO ANTICIPATE REVENUE, AND APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”**

**WHEREAS**, the Sheriff deposited \$3,747.45 with the County Treasurer in the General Fund for various reasons and would like \$123.15 appropriated in the Sheriff’s Budget and \$3,624.30 appropriated in the Juvenile Detention Budget; and,

**WHEREAS**, the Sheriff deposited \$240.00 with the County Treasurer in the Boating Safety Fund for donations, which he would like appropriated in the Sheriff’s Budget; and,

**WHEREAS**, the Sheriff deposited \$804.95 with the County Treasurer in the Detention Facility Fund for extraditions and restitution, which he would like appropriated in the County Jail Budget; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That Anticipated Revenues for the General Fund are \$3,747.45, and the Quorum Court may appropriate \$123.15 to the Sheriff’s Budget and \$3,624.30 to the Juvenile Detention Budget.

**SECTION 6.** That the sum mentioned in Section 1 represents an increase of \$3,624.30 to the Juvenile Detention Budget.

**SECTION 7.** That the sum mentioned in Section 2 represents an increase of \$240.00 in the Boating Safety Fund Anticipated Revenues.

**SECTION 8.** That the sum mentioned in Section 2 represents an increase of \$240.00 to the Sheriff's Budget.


**SECTION 9.** That the sum mentioned in Section 3 represents an increase of \$804.95 to the Detention Facility Fund Anticipated Revenues.

**SECTION 10.** That the sum mentioned in Section 3 represents an increase of \$804.95 to the County Jail Budget.
