

**APPROPRIATION ORDINANCE NO. O-21-43**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**“AN ORDINANCE TO AMEND THE 2021 GARLAND COUNTY BUDGET ORDINANCE O-20-35; TO ANTICIPATE REVENUE, APPROPRIATE, AND TRANSFER FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”**

**WHEREAS**, the County Judge requests an appropriation of \$5,300.00 in the American Rescue Plan (ARP), County Judges Budget to pay for a clean air system installed on the first floor and in the basement of the Garland County Courthouse at 501 Ouachita Avenue; and,

**WHEREAS**, the County Judge requests an appropriation of \$10,000.00 in the County General Fund, with \$5,000.00 posted to the District Court Building Budget and \$5,000.00 posted to the Juvenile Court Building to pay for repairs to the sprinkler system at 607 Ouachita Avenue; and,

**WHEREAS**, the Sheriff requests an appropriation of \$11,530.03 in the County General Fund, Sheriff’s Budget to pay for fleet liability insurance costs; and,

**WHEREAS**, the Sheriff deposited \$5,031.75 with the County Treasurer from the National School Lunch Program and would like it appropriated in the General Fund, Juvenile Detention Budget; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the sum of \$5,300.00 is hereby appropriated from the ARP Fund to the County Judges Budget.

**SECTION 2.** That the sum of \$5,000.00 is hereby appropriated from County General Fund to the District Court Building Budget.

**SECTION 3.** That the sum of \$5,000.00 is hereby appropriated from County General Fund to the Juvenile Court Building Budget.

**SECTION 4.** That the sum of \$11,530.03 is hereby appropriated from County General Fund to the Sheriff’s Budget.

**SECTION 5.** The Anticipated Revenues for the General Fund are \$5,031.75, and the Quorum Court may appropriate these funds in the Juvenile Detention Budget.

**SECTION 6.** That the sum mentioned in Section 1 does not affect the ARP Fund Anticipated Revenues.

**SECTION 7.** That the sum mentioned in Section 1 represents an increase of \$5,300.00 in the County Judge's Budget.

**SECTION 8.** That the sum mentioned in Section 2 does not affect the County General Fund Anticipated Revenues.

**SECTION 9.** That the sum mentioned in Section 2 represents an increase of \$5,000.00 in the District Court Building Budget.


**SECTION 10.** That the sum mentioned in Section 3 represents an increase of \$5,000.00 in the Juvenile Court Building Budget.


**SECTION 11.** That the sum mentioned in Section 4 does not affect the County General Fund Anticipated Revenues.


**SECTION 12.** That the sum mentioned in Section 4 represents an increase of \$11,530.03 in the Sheriff's Budget.
