

APPROPRIATION ORDINANCE NO. O-19-05

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; AND TO APPROPRIATE FUNDS THEREFORE TO THE SHERIFF’S BUDGET, THE JUVENILE DETENTION BUDGET, AND THE COUNTY JAIL BUDGET; AND, FOR OTHER PURPOSES.”

WHEREAS, the Sheriff deposited \$40,552.56 with the County Treasurer in the General Fund for insurance reimbursements, a donation, two months of National School Lunch reimbursements and a reimbursement on unclaimed property; and

WHEREAS, the Sheriff deposited \$2,578.00 with the County Treasurer in the Detention Facility Fund for an insurance reimbursement, restitution, and extradition; and

WHEREAS, the Sheriff requested an appropriation of \$36,236.24 in the Sheriff’s Budget and \$4,316.32 in the Juvenile Detention Budget from funds received in the General Fund; and

WHEREAS, the Sheriff requested an appropriation of \$2,578.00 in the County Jail Budget from funds received in the Detention Facility Fund; and

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. Anticipated Revenues for the General Fund are \$40,552.56, and the Quorum Court may appropriate these revenues.

SECTION 2. That the sum of \$36,236.24 is hereby appropriated from the County General Fund to the Sheriff’s Budget in the following manner:

SECTION 3. That the sum of \$4,316.32 is hereby appropriated from the County General Fund to the Juvenile Detention Budget in the following manner:

SECTION 4. Anticipated Revenues for the Detention Facility Fund are \$2,578.00 and the Quorum Court may appropriate these revenues in the following manner.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$40,552.56 to the County General Fund Anticipated Revenues.


SECTION 6. That the sum mentioned in Section 2 represents an increase of \$36,236.24 to the Sheriff's Budget.


SECTION 7. That the sum mentioned in Section 3 represents an increase of \$4,316.32 to the Juvenile Detention Budget.

SECTION 8. That the sum mentioned in Section 4 represents an increase of \$2,578.00 to the Detention Facility Fund Anticipated Revenues.

SECTION 9. That the sum mentioned in Section 4 represents an increase of \$2,578.00 to the County Jail Budget.
