

APPROPRIATION ORDINANCE NO. O-19-09

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; AND TO APPROPRIATE AND TRANSFER FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the County Judge received a refund for the buyout of a GPS contract of \$5,703.06 and is requesting an appropriation in the Solid Waste Fund; and,

WHEREAS, the County Judge requested to transfer and appropriate the above funds from Solid Waste to the General Fund, General Services Budget to purchase office furniture for the Environmental Inspections Department from the Finance Department; and,

WHEREAS, the Juvenile Circuit Judge, Division II requested the 2019 beginning balance Anticipated Revenues in the Circuit Court Automation Fund be increased by \$4,318.57 for funds not used in 2018; and,

WHEREAS, the Juvenile Circuit Judge, Division II requested an appropriation of \$4,318.57 in the Circuit Court Automation Budget to pay for four new computers; and,

WHEREAS, previously in 2018 funds were transferred from the General Fund to provide for overtime pay in the Selective Traffic Enforcement Program (STEP) Fund; and,

WHEREAS, the Sheriff received reimbursements from the Arkansas State Police for the STEP Fund and has requested an appropriation and transfer to reimburse the General Fund \$5,000.00; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the Anticipated Revenues for the Solid Waste Fund are \$5,703.06 and the Quorum Court may appropriate 100% of these revenues to the Solid Waste Budget:

SECTION 2. That the Anticipated Revenues for the General Fund are \$5,703.06 and the Quorum Court may appropriate 100% of these revenues to the General Services Budget:

SECTION 3. That the sum of \$4,318.57 is hereby appropriated from the Circuit Court Automation Fund to the Circuit Court Automation Budget:

SECTION 4. That the Anticipated Revenues for the STEP Fund are \$5,000.00 and the Quorum Court may appropriate 100% of these revenues to the Sheriff's Budget:

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$5,703.06 to the Solid Waste Fund Anticipated Revenues.

SECTION 6. That the sum mentioned in Section 1 represents an increase of \$5,703.06 to the Solid Waste Budget.

SECTION 7. That the sum mentioned in Section 2 represents an increase of \$5,703.06 to the General Fund Anticipated Revenues.

SECTION 8. That the sum mentioned in Section 2 represents an increase of \$5,703.06 to the General Services Budget.

SECTION 9. That the sum mentioned in Section 3 has no effect on the Circuit Court Automation Fund Anticipated Revenues.

SECTION 10. That the sum mentioned in Section 3 represents an increase of \$4,318.57 to the Circuit Court Automation Budget.


SECTION 11. That the sum mentioned in Section 4 represents an increase of \$5,000.00 to the STEP Fund Anticipated Revenues.

SECTION 12. That the sum mentioned in Section 4 represents an increase of \$5,000.00 to the Sheriff's Budget.

SECTION 13. That the County Treasurer and the County Judge are hereby authorized to execute completion of transfer as follows:



SECTION 4. That the Anticipated Revenues for the STEP Fund are \$5,000.00 and the Quorum Court may appropriate 100% of these revenues to the Sheriff's Budget:

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$5,703.06 to the Solid Waste Fund Anticipated Revenues.

SECTION 6. That the sum mentioned in Section 1 represents an increase of \$5,703.06 to the Solid Waste Budget.

SECTION 7. That the sum mentioned in Section 2 represents an increase of \$5,703.06 to the General Fund Anticipated Revenues.

SECTION 8. That the sum mentioned in Section 2 represents an increase of \$5,703.06 to the General Services Budget.

SECTION 9. That the sum mentioned in Section 3 has no effect on the Circuit Court Automation Fund Anticipated Revenues.

SECTION 10. That the sum mentioned in Section 3 represents an increase of \$4,318.57 to the Circuit Court Automation Budget.


SECTION 11. That the sum mentioned in Section 4 represents an increase of \$5,000.00 to the STEP Fund Anticipated Revenues.
