

APPROPRIATION ORDINANCE NO. O-19-12

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; AND TO APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the County Judge requested an appropriation of \$11,245.00 in the Nine One One Budget to pay for mapping software from the Emergency 911 Reserve Fund; and,

WHEREAS, the County Judge deposited \$633.02 in the Solid Waste Fund from an insurance reimbursement and he would like it appropriated to the Solid Waste Budget for repairs; and,

WHEREAS, the County Judge requested transfer of \$48,500.00 in the Solid Waste Budget to purchase a 2002 Caterpillar 140 Motor Grader from the County Road Fund; and,

WHEREAS, the County Judge requested an appropriation of \$48,500.00 in the County Road Budget to purchase a 2018 John Deere 670 Motor Grader; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the sum of \$11,245.00 is hereby appropriated from the Emergency 911 Reserve Fund to the Nine One One Budget.

SECTION 2. That Anticipated Revenues for the Solid Waste Fund are increased by \$633.02, and the Quorum Court may appropriate 100% of these revenues to the Solid Waste Budget.

SECTION 3. That Anticipated Revenues for the County Road Fund are increased by \$48,500.00, and the Quorum Court may appropriate 100% of these revenues to the County Road Budget.

2000.0200.4004	Machinery & Equipment	\$48,500.00

SECTION 4. That the sum mentioned in Section 1 has no effect on the Emergency 911 Reserve Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$11,245.00 to the Nine One One Budget.

SECTION 6. That the sum mentioned in Section 2 represents an increase of \$633.02 to the Solid Waste Fund Anticipated Revenues.

SECTION 7. That the sum mentioned in Section 2 represents an increase of \$633.02 to the Solid Waste Budget.

SECTION 8. That the sum mentioned in Section 4 represents an increase of \$48,500.00 to the County Road Fund Anticipated Revenues.

SECTION 9. That the sum mentioned in Section 4 represents an increase of \$48,500.00 to the County Road Budget.

SECTION 10. That the County Treasurer and the County Judge are hereby authorized to execute the transfer as follows:
