

APPROPRIATION ORDINANCE NO. O-19-14

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; ANTICIPATE REVENUE; TRANSFER AND TO APPROPRIATE FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the Sheriff deposited \$3,711.37 with the County Treasurer in the General Fund for two months of National School Lunch reimbursements and he would like to appropriate these funds to the Juvenile Detention Budget; and,

WHEREAS, the Sheriff deposited \$5,417.78 with the County Treasurer in the Detention Facility Fund for insurance reimbursements and he would like to appropriate these funds in the County Jail Budget; and,

WHEREAS, the Sheriff requested an appropriation of \$15,894.36 in the County Jail Budget, Detention Facility Reserve Fund to pay for acoustical paneling materials to be installed in the remaining pods of the Detention Facility; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That Anticipated Revenues for the General Fund are \$3,711.37, and the Quorum Court may appropriate these revenues to the Juvenile Detention Budget.

SECTION 2. That Anticipated Revenues for the Detention Facility Fund are \$5,417.78 and the Quorum Court may appropriate these revenues to the County Jail Budget.

SECTION 3. That the sum of \$15,894.36 is hereby appropriated from the Detention Facility Reserve Fund to the County Jail Budget.

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$3,711.37 to the County General Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$3,711.37 to the Juvenile Detention Budget.

SECTION 6. That the sum mentioned in Section 2 represents an increase of \$5,417.78 to the Detention Facility Fund Anticipated Revenues.


SECTION 7. That the sum mentioned in Section 2 represents an increase of \$5,417.78 to the County Jail Budget.

SECTION 8. That the sum mentioned in Section 3 has no effect on the Detention Facility Reserve Fund Anticipated Revenues.


SECTION 9. That the sum mentioned in Section 3 represents an increase of \$15,894.36 to the County Jail Budget.
