

**APPROPRIATION ORDINANCE NO. O-19-16**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; TO ANTICIPATE REVENUE, AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”**

**WHEREAS**, the Sheriff requests an appropriation of \$25,814.27 in the Selective Traffic Enforcement Program (STEP) Fund for monies not expended in 2018; and,

**WHEREAS**, the Sheriff requests an appropriation of \$2,944.46 in the Bulletproof Vest Grant Fund for monies not expended in 2018; and,

**WHEREAS**, the Sheriff requests an appropriation transfer for \$2,868.90 from the Ouachita Memorial Hospital (OMH) Sale Fund to the Bulletproof Vest Grant Fund until reimbursements are received; and,

**WHEREAS**, the Circuit Court Division II Judge requests an appropriation transfer for \$.02 from the Juvenile Accountability Block Grant Fund to the General Fund to close out the grant; and,

**WHEREAS**, the Sheriff requests an appropriation of \$11,045.23 in the Edward Byrne Justice Assistance Grant (JAG) Fund for monies not expended in 2018; and,

**WHEREAS**, the Prosecuting Attorney requests an appropriation of \$5,428.61 in the Victims of Crime Act (VOCA) Fund for monies not expended in 2018; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the Anticipated Revenues for the STEP Fund are \$25,814.27 and the Quorum Court may appropriate these revenues in the Sheriff's Budget.

**SECTION 13.** That the sum mentioned in Section 4 represents an increase of \$.02 to the Juvenile Accountability Block Grant Fund Anticipated Revenues.

**SECTION 14.** That the sum mentioned in Section 4 represents an increase of \$.02 to the Circuit Court Division II Budget.

**SECTION 15.** That the sum mentioned in Section 5 represents an increase of \$11,045.23 to the JAG Fund Anticipated Revenues.


**SECTION 16.** That the sum mentioned in Section 5 represents an increase of \$11,045.23 to the Sheriff's Budget.


**SECTION 17.** That the sum mentioned in Section 6 represents an increase of \$5,428.61 to the VOCA Fund Anticipated Revenues.


**SECTION 18.** That the sum mentioned in Section 6 represents an increase of \$5,428.61 to the Prosecuting Attorney's Budget.
