

APPROPRIATION ORDINANCE NO. O-19-22

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE SHERIFF AND CIRCUIT COURT DIVISION II BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the Circuit Court Division II Juvenile Judge was awarded a \$1,550.00 grant from the Arkansas Community Foundation in support of the Teen Court Program. He would like these funds appropriated in the Garland County Teen Court Fund; and,

WHEREAS, the Sheriff requests a transfer of personal services line items in the Selective Traffic Enforcement Program (STEP); and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. Anticipated Revenues for the Garland County Teen Court Fund are \$1,550.00, and the Quorum Court may appropriate up to 100% of these revenues.




SECTION 2. That the County Judge is hereby authorized to execute completion of the transfers in the STEP Fund as follows:
