

APPROPRIATION ORDINANCE NO. O-19-27

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; ANTICIPATE REVENUE, TRANSFER, AND TO APPROPRIATE FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the Sheriff deposited \$9,217.89 with the County Treasurer in the General Fund for three months of National School Lunch reimbursements, restitution, insurance proceeds, and a rebate. He would like to appropriate \$6,387.60 to the Juvenile Detention Budget; and \$2,830.29 to the Sheriff’s Budget; and,

WHEREAS, the Sheriff deposited \$2,607.96 with the County Treasurer in the Detention Facility Fund for extraditions, restitution, and insurance proceeds. He would like to appropriate these funds to the County Jail Budget; and,

WHEREAS, the Sheriff would like to contract with National Park Community College for a patrol vehicle to be used by the Resource Officer assigned to that location. The cost and appropriation for the vehicle will be \$35,987.00 including outfitting the vehicle. If approved, the college will pay the county \$599.78 for 60 months, with six months being paid in 2019.

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That Anticipated Revenues for the General Fund are \$9,217.89, and the Quorum Court may appropriate \$6,387.60 to the Juvenile Detention Budget and \$2,830.29 to the Sheriff’s Budget.

SECTION 2. That Anticipated Revenues for the Detention Facility Fund are \$2,607.96 and the Quorum Court may appropriate these revenues to the County Jail Budget.

SECTION 3. That Anticipated Revenues for the General Fund are \$3,598.68 and the sum of \$35,987.00 is hereby appropriated from the General Fund to the Sheriff’s Budget.

SECTION 6. That the sum mentioned in Section 1 represents an increase of \$2,830.29 to the Sheriff's Budget.

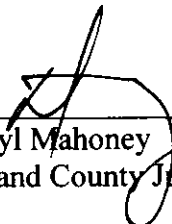
SECTION 7. That the sum mentioned in Section 2 represents an increase of \$2,607.96 to the Detention Facility Fund Anticipated Revenues.

SECTION 10. That the sum mentioned in Section 3 represents an increase of \$35,987.00 to the Sheriff's Budget.
