

**APPROPRIATION ORDINANCE NO. O-19-38**

**BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; ANTICIPATE REVENUES, AND TO APPROPRIATE FUNDS THEREFORE TO THE JUVENILE DETENTION AND THE PROSECUTING ATTORNEY’S BUDGETS; AND, FOR OTHER PURPOSES.”**

**WHEREAS**, the Sheriff applied for and received a Juvenile Grant in Aid grant award from the Department of Finance and Administration for \$28,574.00 and is requesting an appropriation of these funds; and,

**WHEREAS**, the Prosecuting Attorney is requesting a transfer of \$3,400.00 in the personal services appropriated line items in the Victims of Crimes ACT Fund; and,

**WHEREAS**, the Finance Committee has previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** Anticipated Revenues for the Juvenile Grant in Aid Fund are \$28,574.00. and the Quorum Court may appropriate up to 100% of these Anticipated Revenues in the Juvenile Detention Budget.


