

APPROPRIATION ORDINANCE NO. O-19-49

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; TO ANTICIPATE REVENUE, AND APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the County Judge deposited \$66,477.98 with the County Treasurer in the General Reserve Capital Improvement Fund, Specials Budget for insurance proceeds received on the Armory roof located at 210 Woodbine; and,

WHEREAS, the County Judge deposited \$1,166.37 with the County Treasurer in the General Fund, Office of Emergency Management Budget for insurance proceeds received on a 2004 Ford Super Duty F350; and,

WHEREAS, the County Judge requests a \$10,000.00 budget transfer in personal services line items for overtime in the Road Fund, County Road Budget; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That Anticipated Revenues for the General Reserve Capital Improvement Fund are \$66,477.98 and the Quorum Court may appropriate these revenues to the Special Projects Budget..

SECTION 2. That Anticipated Revenues for the General Fund are \$1,166.37, and the Quorum Court may appropriate these revenues to the Office of Emergency Management Budget.

SECTION 3. That the County Judge requests to transfer \$10,000.00 in the Road Fund, County Road Budget for salaries, part-time to overtime.

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$66,477.98 to the General Reserve Capital Improvement Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$66,477.98 to the Special Project's Budget.

SECTION 6. That the sum mentioned in Section 2 represents an increase of \$1,166.37 to the General Fund Anticipated Revenues.

SECTION 7. That the sum mentioned in Section 2 represents an increase of \$1,166.37 to the Office of Emergency Management Budget.

SECTION 8. That the sum mentioned in Section 3 has no effect on the Road Fund Anticipated Revenues.

SECTION 9. That the sum mentioned in Section 3 has no effect on the County Road Budget.
