

APPROPRIATION ORDINANCE NO. O-19-56

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; TO ANTICIPATE REVENUE, AND APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS IN THE SHERIFF’S OFFICE; AND, FOR OTHER PURPOSES.”

WHEREAS, the Sheriff deposited \$6,591.09 with the County Treasurer in the General Fund for one month of National School Lunch reimbursement, refunds, and insurance proceeds. He would like to appropriate \$2,492.54 to the Juvenile Detention Budget, and \$4,098.55 to the Sheriff’s Budget; and,

WHEREAS, the Sheriff deposited \$269.06 with the County Treasurer in the Detention Facility Fund for refund and reimbursement to the County Jail Budget; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That Anticipated Revenues for the General Fund are \$6,591.09, and the Quorum Court may appropriate \$2,492.54 to the Juvenile Detention Budget and \$4,098.55 to the Sheriff’s Budget.

SECTION 6. That the sum mentioned in Section 2 represents an increase of \$269.06 in the Detention Facility Fund Anticipated Revenues.

SECTION 7. That the sum mentioned in Section 2 represents an increase of \$269.06 in the County Jail Budget.
