

APPROPRIATION ORDINANCE NO. O-19-48

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2019 GARLAND COUNTY BUDGET ORDINANCE O-18-56; TO ANTICIPATE REVENUE, TO APPROPRIATE, AND TRANSFER FUNDS THEREFORE TO THE ELECTION COMMISSION AND THE SHERIFF’S BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the Election Commission requests a \$16,000.00 budget transfer to pay for a special election called by Governor Aca Hutchinson; and,

WHEREAS, the Sheriff deposited \$3,939.88 with the County Treasurer in the General Fund for insurance proceeds received on a 2018 Ford Police interceptor vehicle and would like to appropriate these funds in the Sheriff’s Budget; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the Election Commission requests to transfer \$16,000 in the General Fund, Election Commission Budget to pay for salaries and social security matching.

SECTION 2. That the Anticipated Revenues for the General Fund are \$3,939.88, and the Quorum Court may appropriate these revenues to the Sheriff’s Budget.

SECTION 3. That the sum mentioned in Section 1 has no effect on the General Fund Anticipated Revenues.

SECTION 4. That the sum mentioned in Section 1 has no effect on the Election Commission Budget.

SECTION 5. That the sum mentioned in Section 2 represents an increase of \$3,939.88 to the General Fund Anticipated Revenues.


SECTION 6. That the sum mentioned in Section 2 represents an increase of \$3,939.88 to the Sheriff’s Budget.


