

**APPROPRIATION ORDINANCE NO. O-18-24**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; AND TO APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

**WHEREAS**, the County Judge requested that the 2018 beginning balance anticipated revenue be increased by \$587,262.52, due to actual revenues received in 2017 being under anticipated; and,

**WHEREAS**, the County Judge received \$976.96 from APERMA for the damage to one of the offices in the District Court Building, and would like to anticipate the revenue in the General Fund; and,

**WHEREAS**, the County Judge requested an appropriation to the General Services Budget in the amount of \$200,000.00 to pay for the design and renovation of the fourth floor, a survey of the existing roof, and exterior of the Garland County Courthouse; and,

**WHEREAS**, the County Judge requested an appropriation to the District Court Building Expenses and the Juvenile Court Building Expenses Budgets in the amount of \$5,000.00 in each budget to repair and do a water test on the Courts Building roof; and,

**WHEREAS**, the County Judge requested an appropriation to the General Services Budget in the amount of \$7,000.00 to replace an electrical panel in the Government Building; and,

**WHEREAS**, the County Judge requested an appropriation to the District Court Building Expenses Budget in the amount of \$976.96 to repair the District Court Building office that was damaged; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** Anticipated revenues for the General Fund are \$588,239.48 and the Quorum Court may appropriate 90% of these Anticipated Revenues.

**SECTION 2.** That the sum of \$207,000.00 is hereby appropriated from the General Fund to the 2018 General Services Budget in the following manner:

**SECTION 3.** That the sum of \$5,000.00 is hereby appropriated from the General Fund to the 2018 Juvenile Court Building Expenses Budget in the following manner:

**SECTION 4.** That the sum of \$5,976.96 is hereby appropriated from the General Fund to the 2018 District Court Building Expenses Budget in the following manner:

**SECTION 5.** That the sum mentioned in Section 1 represents an increase of \$588,239.48 to the 2018 County General Fund Anticipated Revenues.


**SECTION 6.** That the sum mentioned in Section 2 represents an increase of \$207,000.00 to the 2018 General Services Budget.

**SECTION 7.** That the sum mentioned in Section 3 represents an increase of \$5,000.00 to the 2018 Juvenile Court Building Expenses Budget.

**SECTION 8.** That the sum mentioned in Section 4 represents an increase of \$5,976.96 to the 2018 District Court Building Expenses Budget.
