

APPROPRIATION ORDINANCE NO. O-18-25

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; AND TO APPROPRIATE FUNDS THEREFORE TO VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

WHEREAS, the County Library requested an appropriation in the amount of \$19,000 to the County Library Budget for part-time employees that were eligible for retirement, but were not reported to the Arkansas Public Retirement System; and,

WHEREAS, the County Judge requested an appropriation in the amount of \$2,500 to the County Road Budget for a part-time employee that was eligible for retirement, but was not reported to the Arkansas Public Retirement System; and,

WHEREAS, the Tax Collector requested an appropriation in the amount of \$20,862 to the Tax Collector’s Budget for a full-time employee that was eligible for retirement, but was not reported to the Arkansas Public Retirement System; and,

WHEREAS, the County Judge requested an appropriation in the amount of \$2,000 to the Financial Management Budget to pay to have retirement data extracted from the AS400 system; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the sum of \$19,000 is hereby appropriated from the County Library Fund to the 2018 County Library Budget in the following manner:

Line Item	Description	Amount
3008.0600.1007	Retirement	\$19,000

SECTION 2. That the sum of \$2,500 is hereby appropriated from the County Road Fund to the 2018 County Road Budget in the following manner:

Line Item	Description	Amount
2000.0200.1007	Retirement	\$2,500

SECTION 3. That the sum of \$20,862 is hereby appropriated from the County General Fund to the 2018 Tax Collector’s Budget in the following manner:

Line Item	Description	Amount
1000.0104.1007	Retirement	\$20,862

SECTION 4. That the sum of \$2,000 is hereby appropriated from the County General Fund to the 2018 Financial Management Budget in the following manner:

Line Item	Description	Amount
1000.0113.3003	Computer Services	\$2,000


SECTION 5. That the sum mentioned in Section 1 represents an increase of \$19,000 to the 2018 County Library Budget.

SECTION 6. That the sum mentioned in Section 2 represents an increase of \$2,500 to the 2018 County Road Budget.

SECTION 7. That the sum mentioned in Section 3 represents an increase of \$20,862 to the 2018 Tax Collector's Budget.

SECTION 8. That the sum mentioned in Section 3 represents an increase of \$2,000 to the 2018 Financial Management Budget.
