

**APPROPRIATION ORDINANCE NO. O-18-35**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; TO APPROPRIATE FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND, FOR OTHER PURPOSES.”

**WHEREAS**, the County Judge requested an appropriation to the General Services Budget for \$20,000 to pay the cost of the Architects and additional bid cost to renovate the fourth floor of the courthouse; and,

**WHEREAS**, the County Judge requested an appropriation to the Animal Control Budget for \$526 to pay sales tax on the slide-in Animal Control Unit; and,

**WHEREAS**, the County Judge requested an appropriation to the Nine-One-One Budget for \$113,226 to pay 911 telephone bills and to purchase a VHF recorder; and,

**WHEREAS**, the County Judge requested an appropriation to the Solid Waste Budget for \$149,200 to pay for a trash can audit and tracking software; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** The sum of \$20,000 is hereby appropriated from the General Fund to the General Services Budget in the following manner:

**SECTION 2.** The sum of \$526 is hereby appropriated from the General Fund to the Animal Control Budget in the following manner:

**SECTION 3.** The sum of \$113,226 is hereby appropriated from the Emergency 911 Fund to the Nine-One-One Budget in the following manner:

**SECTION 4.** The sum of \$149,200 is hereby appropriated from the Solid Waste Fund to the Solid Waste Budget in the following manner:

**SECTION 5.** That the sum mentioned in Section 1 & 2 have no effect on the General Fund Anticipated Revenues.

**SECTION 6.** That the sum mentioned in Section 1 represents an increase of \$20,000 to the General Services Budget.


**SECTION 7.** That the sum mentioned in Section 2 represents an increase of \$526 to the Animal Control Budget.


**SECTION 8.** That the sum mentioned in Section 3 has no effect on the Emergency 911 Fund Anticipated Revenues.


**SECTION 9.** That the sum mentioned in Section 3 represents an increase of \$113,226 to the Nine-One-One Budget.
