

**APPROPRIATION ORDINANCE NO. O-18-37**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; AND TO APPROPRIATE FUNDS THEREFORE TO THE VARIOUS GRANT BUDGETS; AND FOR OTHER PURPOSES.”

**WHEREAS**, the County Judge applied for and received a grant award from the Arkansas Supreme Court Committee and Emergency Preparedness in the Court Security Grant Budget for \$5,941.08; and,

**WHEREAS**, the County Judge has requested an appropriation in the Court Security Grant Fund for \$5,941.08 to be used to purchase a bullet resistant window and an AWIN radio; and,

**WHEREAS**, the County Judge would like to appropriate and transfer \$2.61 from the Fountain Lake Volunteer Fire Department Grant Fund to the General Fund as approved by the Arkansas GIF II Fire Protection Grant Administrator; and,

**WHEREAS**, the County Judge would like to appropriate and transfer \$25,451.69 from the Hazard Mitigation Grant Fund to the OMH Sale Fund as a reimbursement; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the Anticipated Revenues for the Court Security Grant Fund are \$5,941.08 and the Quorum Court may appropriate up to 100% of these Anticipated Revenues.

**SECTION 6.** That the sum mentioned in Section 2 represents an increase of \$2.61 to the Fountain Lake Volunteer Fire Department Grant Fund Anticipated Revenues.


**SECTION 7.** That the sum mentioned in Section 2 represents an increase of \$2.61 to the Fire Department Budget.




**SECTION 9.** That the sum mentioned in Section 3 represents an increase of \$25,451.69 to the Grant in Aid- Public Safety Budget.
