

**APPROPRIATION ORDINANCE NO. O-18-45**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; AND TO APPROPRIATE FUNDS THEREFORE TO THE VARIOUS BUDGETS; AND FOR OTHER PURPOSES.”

**WHEREAS**, the County Tax Collector requests an appropriation of \$3,695.00 in the Tax Collectors Automation Fund, Tax Collector’s Budget for overtime pay and benefits; and,

**WHEREAS**, the Prosecuting Attorney requests a transfer for \$2,135.96 from part-time salaries to various line items in the Victims of Crime Act (VOCA) Fund, Prosecuting Attorney’s Budget; and,

**WHEREAS**, the County Judge requests a transfer for \$7,673.00 in the Solid Waste Budget from various personal line items to transfers out; and,

**WHEREAS**, the County Judge requests to increase anticipated revenues for line item transfers in and appropriate \$7,673.00 in the Solid Waste House to House Budget to pay for overtime and benefits; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the sum of \$3,695.00 is hereby appropriated from the Tax Collectors Automation Fund to the Tax Collector’s Budget in the following manner.

**SECTION 8.** That the sum mentioned in Section 2 has no effect on the Prosecuting Attorney's Budget.


**SECTION 9.** That the sum mentioned in Section 3 has no effect on the Solid Waste Fund Anticipated Revenues.
