

**APPROPRIATION ORDINANCE NO. O-18-50**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55, AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO VARIOUS BUDGETS; AND FOR OTHER PURPOSES.”

**WHEREAS**, the Sheriff has been awarded a Selective Traffic Enforcement Program (STEP) grant for \$53,000.00; and,

**WHEREAS**, the Sheriff is requesting an appropriation for \$24,962.91 in the 2018 budget and the remaining \$28,037.09 in the 2019 budget for personal services in the Sheriff’s Budget; and,

**WHEREAS**, the Prosecuting Attorney is requesting a transfer in from the Victim Assistance Fund to the Victims of Crime Act (VOCA) grant Fund for \$5,268.83 and an appropriation for \$3,508.38 to cover unforeseen cost. She is also, requesting to un-appropriate several line items and re-appropriate where necessary in the Prosecuting Attorney’s Budget, 2017/2018 VOCA Fund to close the grant; and,

**WHEREAS**, the Prosecuting Attorney has been awarded a 2018/2019 VOCA grant for \$92,282.77, which includes the grant award of \$73,811.17, and the county match of \$18,471.60. The grant will require an appropriation /transfer from the General Fund for the 20% match; and,

**WHEREAS**, the Prosecuting Attorney is requesting an appropriation for \$23,900.61 in the 2018 budget and the remaining \$68,382.16 in the 2019 budget for personal services and special legal in the Prosecuting Attorney’s Budget; and,

**WHEREAS**, the Prosecuting Attorney has been awarded a Drug Task Force (DTF) grant for \$26,538.53 for 2018; and,

**WHEREAS**, the Prosecuting Attorney is requesting an appropriation for \$26,538.53 in the Prosecuting Attorney’s Budget for personal services; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** Anticipated Revenues for the STEP Fund are \$24,962.91 and the Quorum Court may appropriate up to 100% of these revenues in the following manner.

**SECTION 11.** That the sum mentioned in Section 4 represents an increase of \$23,900.61 to the VOCA Fund Anticipated Revenues.

**SECTION 12.** That the sum mentioned in Section 4 represents an increase of \$23,900.61 to the Prosecuting Attorney's Budget.

**SECTION 13.** That the sum mentioned in Section 5 has no effect on the General Fund Anticipated Revenues.


**SECTION 14.** That the sum mentioned in Section 5 represents an increase of \$18,471.60 to the Prosecuting Attorney's Budget.


**SECTION 15.** That the sum mentioned in Section 6 represents an increase of \$26,538.53 to the DTF Fund Anticipated Revenues.


**SECTION 16.** That the sum mentioned in Section 6 represents an increase of \$26,538.53 to the Prosecuting Attorney's Budget.
