

**APPROPRIATION ORDINANCE NO. O-18-51**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2018 GARLAND COUNTY BUDGET ORDINANCE O-17-55; AND TO APPROPRIATE FUNDS THEREFORE TO THE SHERIFF’S BUDGET, THE JUVENILE DETENTION BUDGET, AND THE COUNTY JAIL BUDGET; AND, FOR OTHER PURPOSES.”

**WHEREAS**, the Sheriff deposited \$4,646.71 with the County Treasurer in the General Fund for insurance reimbursements, three months of National School Lunch reimbursements and restitution; and,

**WHEREAS**, the Sheriff deposited \$350.46 with the County Treasurer in the Detention Facility Fund for restitution and extradition; and,

**WHEREAS**, the Sheriff requested an appropriation of \$427.27 in the Sheriff’s Budget and \$4,219.44 in the Juvenile Detention Budget from funds received in the General Fund; and,

**WHEREAS**, the Sheriff requested an appropriation of \$350.46 in the County Jail Budget from funds received in the Detention Facility Fund; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** Anticipated Revenues for the General Fund are \$4,646.71, and the Quorum Court may appropriate these revenues.

**SECTION 2.** That the sum of \$427.27 is hereby appropriated from the County General Fund to the 2018 Sheriff’s Budget in the following manner:

**SECTION 3.** That the sum of \$4,219.44 is hereby appropriated from the County General Fund to the 2018 Juvenile Detention Budget in the following manner:

**SECTION 4.** Anticipated Revenues for the Detention Facility Fund are \$350.46, and the Quorum Court may appropriate these revenues in the following manner.

**SECTION 5.** That the sum mentioned in Section 1 represents an increase of \$4,646.71 to the County General Fund Anticipated Revenues.


**SECTION 6.** That the sum mentioned in Section 2 represents an increase of \$427.27 to the Sheriff's Budget.


**SECTION 7.** That the sum mentioned in Section 3 represents an increase of \$4,219.44 to the Juvenile Detention Budget.

**SECTION 8.** That the sum mentioned in Section 4 represents an increase of \$350.46 to the Detention Facility Fund Anticipated Revenues.

**SECTION 9.** That the sum mentioned in Section 4 represents an increase of \$350.46 to the 2018 County Jail Budget.
