

APPROPRIATION ORDINANCE NO. O-17-02

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2017 GARLAND COUNTY BUDGET ORDINANCE O-16-95; AND TO APPROPRIATE FUNDS THEREFORE TO THE SHERIFF’S DEPARTMENT BUDGET, COUNTY ROAD BUDGET, AND SOLID WASTE BUDGET; AND, FOR OTHER PURPOSES.”

WHEREAS, the Garland County Judge and Sheriff have deposited \$243,319.50 with the County Treasurer for the sale of auctioned items; and,

WHEREAS, the Sheriff has requested an appropriation to the Sheriff’s Department Budget in the amount of \$3,920.50 for the sale of auctioned items; and,

WHEREAS, the County Judge has requested an appropriation to the County Road Budget in the amount of \$38,140.00 for the sale of auctioned items; and,

WHEREAS, the County Judge has requested an appropriation to the Solid Waste Budget in the amount of \$201,259.00 for sale of auctioned items; and,

WHEREAS, the Finance Committee has previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the sum of \$3,920.50 is hereby appropriated from the County General Fund to the 2017 Sheriff’s Department Budget in the following manner:

SECTION 2. That the sum of \$38,140.00 is hereby appropriated from the County Road Fund to the 2017 County Road Budget in the following manner:

2000.0200.2002	Small Equipment	38,140.00

SECTION 3. That the sum of \$201,259.00 is hereby appropriated from the Solid Waste Fund to the 2017 Solid Waste Budget in the following manner:

Line Item	Description	Amount
3009.0700.4004	Machinery & Equipment	201,259.00

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$3,920.50 to the 2017 Sheriff's Department Budget.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$3,920.50, to the 2017 County General Fund Anticipated Revenues.


SECTION 6. That the sum mentioned in Section 2 represents an increase of \$38,140.00 to the 2017 County Road Budget.


SECTION 7. That the sum mentioned in Section 2 represents an increase of \$38,140.00 to the 2017 County Road Fund Anticipated Revenues.

SECTION 8. That the sum mentioned in Section 3 represents an increase of \$201,259.00 to the 2017 Solid Waste Budget.

SECTION 9. That the sum mentioned in Section 3 represents an increase of \$201,259.00 to the 2017 Solid Waste Fund Anticipated Revenues.
