

APPROPRIATION ORDINANCE NO. O-17-07

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS,
AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND THE 2017 GARLAND COUNTY BUDGET ORDINANCE O-16-95, AND TO APPROPRIATE/TRANSFER FUNDS FROM THE TRANSFER OUT BUDGET AND THE COUNTY JUDGE BUDGET; AND, FOR OTHER PURPOSES."

WHEREAS, previously Ordinances O-16-48 and O-16-64 provided appropriations for grant funding for the Courthouse Improvement Grant expenditures; and,

WHEREAS, an additional appropriation/transfer of \$25,200.05 from the General Fund has been requested to provide for additional expenditures; and,

WHEREAS, the Finance Committee has previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS:

SECTION 1. That the sum of \$25,200.05 is hereby appropriated from the General Fund to the 2017 Transfer out Budget in the following manner:

SECTION 2. That the sum of \$25,200.05 is hereby appropriated from the AHPP Courthouse Improvement Grant Fund to the 2017 County Judge Budget in the following manner:

3553.0100.4002	Building Improvements	\$25,200.05

SECTION 3. That the sum mentioned in Section 1 represents an increase of \$25,200.05 to the 2017 Transfer Out Budget.

SECTION 4. That the sum mentioned in Section 1 has no effect on the General Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 2 represents an increase of \$25,200.05 to County Judge Budget.

SECTION 6. That the sum mentioned in Section 2 represents an increase of \$25,200.05 to the AHPP Courthouse Improvement Grant Fund Anticipated Revenues.

SECTION 7. That the County Treasurer and County Judge are hereby authorized to execute completion of the above listed transfer.
