

APPROPRIATION ORDINANCE NO. 0-17-09

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2017 GARLAND COUNTY BUDGET ORDINANCE O-16-95; AND TO APPROPRIATE FUNDS THEREFORE TO THE SHERIFF’S DEPARTMENT BUDGET, AND THE JUVENILE DETENTION BUDGET; AND, FOR OTHER PURPOSES.”

WHEREAS, the Garland County Sheriff has deposited \$21,211.18 with the County Treasurer for insurance reimbursements for damages to two vehicles, a rebate from GM, a donation from Fred’s Pharmacy and National School Reimbursements for 3 months; and,

WHEREAS, the Sheriff has requested an appropriation in the amount of \$21,211.18 for reimbursements, rebates, and donations; and,

WHEREAS, the Finance Committee has previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the sum of \$12,229.47 is hereby appropriated from the County General Fund to the 2017 Sheriff’s Department Budget in the following manner:

SECTION 2. That the sum of \$8,681.71 is hereby appropriated from the County General Fund to the 2017 Juvenile Detention Budget in the following manner:

SECTION 3. That the sum of \$300.00 is hereby appropriated from the Boating Safety Fund to the 2017 Sheriff’s Department Budget in the following manner:

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$12,229.47 to the 2017 Sheriff Department Budget.

SECTION 5. That the sum mentioned in Section 1 represents an increase of \$12,229.47 to the 2017 County General Fund Anticipated Revenues.

SECTION 6. That the sum mentioned in Section 2 represents an increase of \$8,681.71 to the 2017 Juvenile Detention Budget.

SECTION 7. That the sum mentioned in Section 2 represents an increase of \$8,681.71 to the 2017 General Fund Anticipated Revenues.

SECTION 8. That the sum mentioned in Section 3 represents an increase of \$300.00 to the 2017 Sheriff's Department Budget.


SECTION 9. That the sum mentioned in Section 3 represents an increase of \$300.00 to the 2017 Boating Safety Fund Anticipated Revenues.
