

APPROPRIATION ORDINANCE NO. 0-17-22

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE TO AMEND THE 2017 GARLAND COUNTY BUDGET ORDINANCE O-16-95, TO ESTABLISH A NEW POSITION AND APPROPRIATE/TRANSFER FUNDS WITHIN THE GARLAND COUNTY JUDGE BUDGET; AND FOR OTHER PURPOSES."

WHEREAS, the County Judge has requested a new full-time Secretary/Receptionist position be established in the County Judge Budget; and,

WHEREAS, the County Judge has requested a transfer \$6,800 from Salaries, part-time to Salaries, full-time in the County Judge Budget; and,

WHEREAS, the County Judge has requested an appropriation of \$13,173 to provide salary and benefits for the newly established position in the County Judge Budget; and,

WHEREAS, the Human Resources and Finance Committees have previously met and approved these request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the sum of \$6,800 is hereby transferred within the County Judge Budget in the following manner:

SECTION 2. That the position of full-time Secretary/Receptionist is hereby established as (PCN 1000.0100.0107) and the sum of \$13,173 is hereby appropriated from the County General Fund to the County Judge Budget in the following manner:

SECTION 4. That the amount mention in Section 2 represents an increase of \$13,173 to the County Judge Budget.

SECTION 5. That the amount mentioned in Section 1 and 2 have no effect to the 2017 County General Fund Anticipated Revenues.
