

APPROPRIATION ORDINANCE NO. 017-29

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2017 GARLAND COUNTY BUDGET ORDINANCE O-16-95; AND TO APPROPRIATE FUNDS THEREFORE TO THE GRANT IN AID-PUBLIC SAFETY BUDGET AND THE COUNTY GENERAL SERVICES BUDGET; AND, FOR OTHER PURPOSES.”

WHEREAS, the Office of Emergency Management received reimbursements from the Arkansas Natural Resources Commission for \$131,098.31 and has requested an appropriation/transfer to reimburse the OMH Sale Fund for funding provided in the Hazard Mitigation Assistance Grant Program Fund; and,

WHEREAS, the Office Of Emergency Services Director has requested an appropriation to the Grant in Aid-Public Safety Budget and the County General Services Budget in the amount of \$516.48 to pay taxes on purchased land; and

WHEREAS, the Finance Committee has previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. Anticipated Revenues for the Hazard Mitigation Assistance Grant Program Fund are \$131,459.50 and the Quorum Court may appropriate up to 100% of these Anticipated Revenues. The sum of \$131,459.50 is hereby appropriated from the Hazard Mitigation Assistance Grant Program Fund to the Grant in Aid-Public Safety Budget in the following manner.

SECTION 2. That the sum of \$155.29 is hereby appropriated from the County General Fund to the General Services Budget in the following manner:

SECTION 3. That the sum mentioned in Section 1 represents an increase of \$131,459.50 to the 2017 Grant in Aid-Public Safety Budget in the Hazard Mitigation Assistance Grant Fund.

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$131,459.50 to the 2017 Hazard Mitigation Assistance Grant Program Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 2 represents an increase of \$155.29 to the 2017 County General Services Budget in the General Fund.

SECTION 6. That the sum mentioned in Section 2 has no effect on the 2017 General Fund Anticipated Revenue.

SECTION 7. That the sum mentioned in Sections 1 represents an increase of \$131,459.50 to the 2017 OMH Sale Fund Anticipated Revenues.

SECTION 8. That the County Treasurer and the County Judge are hereby authorized to execute completion of transfers as follows:
