

ORDINANCE NO. 0-17-52

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO PLACE THE MORNING STAR FIRE PROTECTION ASSOCIATION, COMMONLY KNOWN AS MORNING STAR FIRE DEPARTMENT, DUES ON THE PROPERTY TAX STATEMENTS, AS AUTHORIZED BY ARKANSAS CODE ANNOTATED §14-20-108, AS AMENDED BY ACT 693 OF 2015; AND FOR OTHER PURPOSES.”

**WHEREAS**, the Morning Star Fire Protection Association, commonly known as Morning Star Fire Department requests the Quorum Court of Garland County to place the fire department dues on the property tax statements, as authorized by Arkansas Code Annotated §14-20-108, as amended by Act 693 of 2015; and,



**SECTION 1.** That as provided by Arkansas Code Annotated §14-20-108, as amended by Act 693 of 2015, the Tax Collector shall place the fire dues of Morning Star Fire Protection Association on the property tax statements, and the Quorum Court hereby dispenses with a special election on the issue.


