

ORDINANCE NO. 0-17-54

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO LEVY THE COUNTY, MUNICIPAL AND SCHOOL TAXES FOR 2017, COLLECTIBLE IN 2018.”

WHEREAS, In accordance with Arkansas Code Annotated 14-14-904 (b) the Quorum Court at its regular meeting in November shall levy the county, municipal and school taxes for the current year; and,

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:


SECTION 5. The City of Fountain Lake, Arkansas, reported no levy of taxes.
