

APPROPRIATION ORDINANCE NO. O-17-56

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2017 GARLAND COUNTY BUDGET ORDINANCE O-16-95; AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE SHERIFF’S BUDGET; AND, FOR OTHER PURPOSES.”

WHEREAS, the Sheriff received reimbursements from the Department of Justice Assistance for \$11,135.42 and requested an appropriation/transfer to reimburse the OMH Sale Fund; and,

WHEREAS, the Sheriff requested an appropriation/transfer of \$11,358.45 from the County General Fund to reimburse the OMH Sale Fund for the county match; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. Anticipated Revenues for the Bulletproof Vest Federal Grant Fund are \$11,135.42 and the Quorum Court may appropriate up to 100% of these Anticipated Revenues. The sum of \$11,135.42 is hereby appropriated from the Bulletproof Vest Federal Grant Fund to the Sheriff’s Budget in the following manner:

SECTION 2. That the sum of \$11,358.45 is hereby appropriated from the County General Fund to the Sheriff’s Budget in the following manner:

SECTION 3. That the sum mentioned in Section 1 represents an increase of \$11,135.42 to the 2017 Sheriff’s Budget.

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$11,135.42 to the 2017 Bulletproof Vest Federal Grant Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 2 represents an increase of \$11,358.45 to the 2017 Sheriff’s Budget.

SECTION 6. That the sum mentioned in Section 2 has no effect on the 2017 General Fund Anticipated Revenue.

SECTION 7. That the sum mentioned in Section 1 represents an increase of \$22,493.87 to the 2017 OMH Sale Fund Anticipated Revenues.

SECTION 8. That the County Treasurer and the County Judge are hereby authorized to execute completion of transfers as follows:
