

APPROPRIATION ORDINANCE NO. 0-17-58

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2017 GARLAND COUNTY BUDGET ORDINANCE O-16-95, AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE SHERIFF’S BUDGET; AND FOR OTHER PURPOSES.”

WHEREAS, the Sheriff has been awarded a 2018 Selective Traffic Enforcement Program (STEP) grant in the amount of \$20,441; and,

WHEREAS, the Sheriff is requesting an appropriation in the amount of \$20,441 and an appropriation/transfer from the OMH Sale Fund to provide payment until reimbursement is made from the Arkansas State Police Commission; and,

WHEREAS, the Finance Committee previously met and approved this request.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. Anticipated Revenues for the Selective Traffic Enforcement Program (STEP) Grant Fund are \$20,441 and the Quorum Court may appropriate up to 100% of these Anticipated Revenues. That the amount of \$20,441 is hereby appropriated from the Selective Traffic Enforcement Program (STEP) Grant Fund to the Sheriff’s Budget in the following manner:

SECTION 2. That the amount of \$20,441 is hereby appropriated from the OMH Sale Fund to the County Special Projects Budget in the following manner:

SECTION 3. That the sum mentioned in Section 1 represents an increase of \$20,441 to the 2017 Sheriff’s Budget.

SECTION 4. That the sum mentioned in Section 1 represents an increase of \$20,441 to the 2017 Selective Traffic Enforcement Program (STEP) Fund Anticipated Revenues.

SECTION 5. That the sum mentioned in Section 2 represents an increase of \$20,441 to the 2017 County Special Projects Budget.

SECTION 6. That the sum mentioned in Section 2 has no effect on the OMH Sale Fund Anticipated Revenues.

SECTION 7. That the County Treasurer and the County Judge are hereby authorized to execute the transfers as follows:
