

**APPROPRIATION ORDINANCE NO. 0-17-59**

BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:

“AN ORDINANCE TO AMEND THE 2017 GARLAND COUNTY BUDGET ORDINANCE O-16-95; AND TO APPROPRIATE/TRANSFER FUNDS THEREFORE TO THE SHERIFF’S BUDGET; AND FOR OTHER PURPOSES.”

**WHEREAS**, the Sheriff has been awarded an eCrash/eCite System grant from the Arkansas State Police; and,

**WHEREAS**, the Sheriff is requesting an appropriation in the amount of \$63,700 and a transfer/appropriation from OMH Sale Fund to provided payment for purchases until reimbursement is made from the Arkansas State Police; and,

**WHEREAS**, the Finance Committee previously met and approved this request.

**NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the eCrash/eCite System Grant Fund is hereby established. Anticipated Revenues for this fund are \$63,700 and the Quorum Court may appropriate up to 100% of these Anticipated Revenues. That the amount of \$63,700 is hereby appropriated from the eCrash/eCite System Grant Fund to the Sheriff’s Budget in the following manner:

**SECTION 2.** That the amount \$63,700 is hereby appropriated from the OMH Sale Fund to the County Special Projects Budget in the following manner:

1800.0112.9999	Transfers Out	\$63,700

**SECTION 3.** That the sum mentioned in Section 1 represents an increase of \$63,700 to the 2017 Sheriff’s Budget.

**SECTION 4.** That the amount mentioned in Section 1 represents an increase of \$63,700 to the 2017 eCrash/eCite System Grant Fund Anticipated Revenues.

**SECTION 5.** That the amount mentioned in Section 2 represents an increase of \$63,700 to the 2017 County Special Projects Budget.

**SECTION 6.** That the amount mentioned in Section 2 has no effect on the 2017 OMH Sale Fund Anticipated Revenues.

**SECTION 7.** That the County Treasurer and the County Judge are hereby authorized to execute completion of transfers as follows:
