**WHEREAS**, the Garland County Quorum Court has determined that the Sheriff’s Office meets eligibility requirements necessary to apply for a Bulletproof Vest Grant; and,


**WHEREAS**, the Sheriff has presented plans to replace bulletproof vests that are expired; and,



**"A RESOLUTION OF THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS, AUTHORIZING THE COUNTY JUDGE TO APPLY FOR THE AMERICAN RESCUE PLAN ACT OF 2021 (ARP) FUNDING TOTALING \$19,304,565.00, TO PROVIDE DIRECT AID TO COUNTIES."**

**WHEREAS**, the American Rescue Plan Act of 2021 was passed by Congress and signed by the President on March 11, 2021, to combat the COVID-19 pandemic, including the public health and economic impacts; and,

**WHEREAS**, the county has lost revenue and incurred expenses due to the COVID-19 pandemic; and,

**WHEREAS**, the Quorum Court has resolved and hereby supports the application for ARP funding; and,

**NOW, THEREFORE, BE IT RESOLVED, BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:**

**SECTION 1.** That the County Judge is hereby authorized to submit an application of formal request to the U.S. Department of the Treasury, Coronavirus Local Fiscal Recovery Fund for the purpose of securing funds in the amount of \$19,304,565.00 to aid and assist the county for the economic hardship caused by the COVID-19 pandemic, to be used pursuant to the applicable rules and regulations.


