BE IT RESOLVED BY THE QUORUM COURT OF GARLAND COUNTY, STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED:

“A RESOLUTION CONFIRMING THE APPOINTMENT OF JAMES A. JACKSON TO THE ROYAL WATER PUBLIC FACILITIES BOARD OF GARLAND COUNTY, ARKANSAS.”

WHEREAS, Ordinance No. O-97-7 which was previously adopted by the Garland County Quorum Court on February 10, 1997, established the Royal Water Public Facilities Board, of Garland County, Arkansas; and,

WHEREAS, the term of James A. Jackson, commissioner of the above referenced board, expires on March 18, 2017; and,

WHEREAS, James A. Jackson had been nominated by the Board to be reappointed for a five (5) year term and has expressed his willingness to serve on the Royal Water Public Facilities Board; and,

WHEREAS, the County Judge has accepted this nomination and recommends confirmation by the Quorum Court.


NOW THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That James A. Jackson is hereby confirmed to a five year term as a member of the Royal Water Public Facilities Board that begins on March 18, 2017 and ends March 18, 2022.


