“A RESOLUTION OF THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS, AUTHORIZING THE COUNTY JUDGE TO PURCHASE GOODS OR SERVICES EXEMPT FROM SOLICITING BIDS AS STATED IN ARKANSAS CODE ANNOTATED §14-22-106 (21).”

WHEREAS, the County Judge request that the Quorum Court approves the purchase of goods or services through competitive bidding or procurement procedures used by the federal government or one of its agencies, another state, or an association of governments or governmental agencies below the state level; and,

WHEREAS, the Road Department and the Solid Waste Department are members of the National Joint Powers Alliance (NJPA) and would like to purchase items through this government association; and,

WHEREAS, the Office of Emergency Management is a member of the General Services Administration Advantage (GSA Advantage) and would like to purchase items through this government association; and,

WHEREAS, the Finance Committee has previously met and approved this request.

NOW, THEREFORE, BE IT RESOLVED, BY THE QUORUM COURT OF GARLAND COUNTY, ARKANSAS:

SECTION 1. That the Garland County Quorum Court approves the exemption of soliciting bids of goods and services from the federal government or one of its agencies, another state, and the two government associations listed above.


